I. Call to Order

a. Jana called the meeting to order @ 3:10 p.m.

II. Approval of Minutes

a. Motion #1 (Marx/Maloney) Minutes from meeting #16-11 May 12, 2016 stand approved as written.

III. Introductions

- a. Jana facilitated introductions and silent roll call was taken.
- b. With 10 voting members in attendance, quorum was met.

IV. Open Forum

a. None

V. Community Reports

- a. ASI President Jana Colombini
 - Jana reported that she attended the CSSA Conference in Long Beach where she successfully secured the bid to host the CSSA Conference at Cal Poly in January 2017.
 - ii. She stated that the ASI Executive Cabinet will launch a TurboVote campaign during fall quarter to encourage students to register to vote.

b. ASCC President - Michael Constable

- i. Michael reported that ASCC Student Government hosted a welcome back event with a barbeque. The event was well attended.
- ii. He stated that he is looking forward to working with SCLC and would love to chat about Cuesta's involvement in the community.

c. City Manager -Katie Lichtig

- i. Katie was proud to announce that the City of San Luis Obispo, Cal Poly and Cuesta College received the Larry Abernathy Award at the International Town Gown Association Conference for the San Luis Obispo Neighborhood Wellness/Community Civility Effort project.
- ii. She reported that Councilmembers will receive the schedule for the budget process at the September 6th City Council meeting. The schedule will determine the major city goals and the direction to take.

d. Residents for Quality Neighborhoods-Carolyn Smith

i. Carolyn reported that Chief Cantrell and Captain Storton attended the July RQN Board of Directors meeting. She stated that it was very informative

- and they had discussions on topics such as noise, crime and who to contact.
- ii. She stated that Jana was RQN's guest at the August meeting and complimented Jana on her goals.
- iii. She reported that she participated in the neighborhood compatibility workshops and the review of the zoning regulations.

VI. Business/Discussion Items

- a. 2016-17 SCLC Meeting Schedule
 - i. Motion #2 (Marx/Constable) "Move to approve the 2016-17 SCLC meeting schedule."
 - ii. Harry expressed his concern about moving the meeting off campus and meetings that were moved to different days. Jana clarified that meetings are generally held on the 3rd Thursday of the month with the exception of when in conflict with Cuesta or Cal Poly finals schedules. The only meeting held off campus was to accommodate President Armstrong's Community Service Awards at the end of the year which many SCLC members are in attendance.
 - iii. Motion passed majority vote.
- b. Voter Designation Form Discussion
 - Jana explained that the discussion is to create consistency for voting members and their designee. The form would basically be for housekeeping measures for nameplates, email alias, etc. These forms would be due annually.
 - ii. Steffanie disagreed with the designation of a proxy stating that it is critical to have a voting member at the table and that it would lose the value of the committee. Members agreed that the designee would be the same person for the year and would be familiar with the discussions. Steffanie reiterated her concern that this is losing the consistency of the committee and enabling what the committee is trying to fix.
 - iii. Michael asked the question "if the Chair or Vice Chair is not available, would their proxy chair the meeting?" Jana stated that technically the meeting would most likely be canceled. Members agreed that there would not be a proxy for the Chair of Vice Chair of SCLC.
 - iv. Motion #3 (Marx/Haddad) "Move to approve the Voter Designee Form."
 - v. Motion passed unanimous voice vote.
- c. SLO Days Presentation

- i. Andrene Kawai-Lenting spoke about the summer orientation SLO Days (formerly SOAR). She stated that there were 11 sessions and 4,700 participants. Their primary focus was what to expect, how to navigate campus, introduction to the community and culture, and the downtown experience.
- ii. She announced that WOW will be held on September 16-18 concluding with the Big Fall Welcome on September 18. Monday and Tuesday will be sessions on college connections, Title IX training, mental health and academics. Classes will begin on Thursday and Friday and WOW will reconvene on Friday night for the Resource Fair. Saturday events include the football game, ASI Events concert, followed by Sunday's Club Showcase.
- iii. Andrene stated that Open House will be on April 6-8, 2017
- d. Make a Difference Day Kirsten Vinther
 - i. Jana stated that Kirsten was unable to attend and that the topic will be on the September meeting agenda.

VII. Neighborhood Wellness Civility Report Update

a. Keith reported that an outreach campaign will launch in October that will go out to students and will include information on the party registration ordinance that will go to City Council on December 6th along with recommendation of what it will look like. Harry stated that he thought it was "overkill" and that it does not represent the voice of each geographic area, i.e. a 99 year old birthday party with 17 people vs. a fraternity party. Jana encouraged members to go back to their constituents. Chief Cantrell stated that the ordinance gives the registered parties an opportunity for a phone call to quiet down vs. receiving a disturbance advisory card (DAC)
