V. Community Reports

- a. ASI President Jana Colombini
 - i. Absent
- b. ASCC President Michael Constable
 - i. Michael reported that the ASCC Senate hosted an ice cream social that was well attended.
 - ii. He announced that Cuesta College is a drop location for the Food Bank during the holidays.
- c. City Manager Derek Johnson
 - i. Derek reported that Council is working on the goal setting process for the 2017-2019 financial plan. Outreach for community input for major city goals have been presented at community forums, through community surveys and meetings with advisory bodies.
 - ii. He reported that the city financials will be presented at the January 10 & 28 meeting with a preliminary budget on May 15. Final budget planning is June 1-6 and adoption by Council is set for June 20.
 - iii. He stated that the city has upgraded 2,220 lights to LED making more clarity. Cal Poly has added new lighting near the Cal Poly housing project.
- d. Residents for Quality Neighborhoods-Carolyn Smith
 - i. Carolyn reported that the Board discussed noise complaints and she commented that complaints are down from last year at this time.

- ii. She shared the chronic offenders list stating that numerous addresses have been on the list for a long time. She stated that an address can apply to be removed from the list.
- iii. She stated that party registration was discussed with Christine Wallace.
- iv. Carolyn reported that the Board discussed parking district procedure to make it more neighbor friendly.

VI. Business/Discussion Items

- a. Good Neighbor Mailer Proposal Brett Raffish
 - i. Brett presented an idea from the ASI Executive Cabinet for a good neighbor mailer. He gave an overview of what the card would contain including a list of suggestions on how to be a good neighbor. The back would include a list of city ordinances, disturbance advisory card's (DAC) the rental inspection program, and items pertinent to student life. He stated that putting it in writing would make students understand exactly what will get them into trouble. He stated that ASI is requesting SCLC to contribute \$2,500 to help fund the project. Derek shared the current good neighbor pamphlet; members agreed that it is out of date. Brett stated that the Executive Cabinet wants students to know that it came from students to students and as of right now, is geared more towards Cal Poly students. Members agreed that if SCLC is contributing, it should be for all Cal Poly & Cuesta students. Members agreed that it is a great idea with possibilities of a grander scale. Michael asked if there is a motion, however, members agreed that it seemed premature and needed more discussion and a mockup of what will be printed. With no motion on the table, the topic was tabled for further discussion.
