## **I. Call to Order**

a. Jana called the meeting to order @ 3:10 p.m.

## II. Approval of Minutes

- a. Approval of Meeting Minutes #17-04, November 17, 2016
  - i. (Constable/Johnson) “Move to approve meeting minutes from meeting #17-04, November 17, 2016”
  - ii. Motion passed unanimous voice vote.

## III. Introductions

- a. Jana facilitated introductions and silent roll call was taken.
- b. With 15 voting members in attendance, quorum was met.

## IV. Open Forum

- a. Harry recommended that the committee discuss the Rental Housing Inspection Program at the next meeting. What do students think? Do they still want it or not.

## V. Community Reports

- a. ASI President -Jana Colombini
  - i. Jana reported that Cal Poly is in dead week with finals week following. Winter quarter break will be from December 5-January 9.
  - ii. Jana announced that the ASI Board of Directors passed two resolutions.
    - 1. #17-02 Resolution to Remove Noise Control from Proposed Safety Enhancement Zone Amendment.
      - a. A copy of the resolution will be sent to all SCLC members.
    - 2. #17-03 ASI Board of Directors’ Support of Services for Undocumented Students
  - iii. She apologized for her absence at the last SCLC meeting due to midterms. She spoke about the Good Neighbor Mailer that will be presented later in the meeting. She stated that she would like to see tangible items come from this committee and believed that the mailer is a good example.
- b. ASCC President – Michael Constable
  - i. Michael reported that he attended the Presidents Open Forum where support of undocumented students was mentioned.
  - ii. He announced that Cuesta is a drop off location for the SLO Food Bank.
- c. City Manager –Derek Johnson
  - i. Derek reported that Council honored the outgoing Council members, Jan Marx, John Ashbaugh and Dan Carpenter. There was a proclamation recognizing Mayor Marx contributions to the community. New Council members will be sworn in in January.

- ii. He stated that at the December 13 Council meeting there will be a report on the Waste Water Treatment plant requesting a loan.
  - iii. He reported that a community forum will be held on January 10 for feedback on the city's major city goals.
- d. Residents for Quality Neighborhoods-Carolyn Smith
- i. Carolyn reported that noise complaints are down significantly from last year.

## VI. Business/Discussion Items

- a. Interfraternity Council Presentation – Danny Halprin
- i. Danny gave a presentation on the Interfraternity Council (IFC) stating that IFC is the governing body for all fraternities at Cal Poly. They pride themselves on providing leadership opportunities, lifelong friendships, service, philanthropic activities, social events, academics, intramural sports, personal development, and group living environments. Philanthropy statistics included 14,942 hours of community service and they raised \$204,725. He stated that there are 1,500 total members with an average of 80 members per chapter. He explained the academic requirements, leadership opportunities and highlights from recruitment.
- b. Good Neighbor Mailer Project Approval – Brett Raffish
- i. Brett reintroduced the topic of the Good Neighbor Mailer stating that the mailer would be sent to 5,000 student renters educating students on laws and ordinances. The goals are to educate the residents in San Luis Obispo of the ordinances they are faced with. To remind the students in the city that it is important to uphold the standards that are set in San Luis Obispo and to create a partnership from Cal Poly, Cuesta, and the City of San Luis Obispo. He shared a mockup of what the mailer could look like stating that there would be a message from the ASI President and ASCC President. The content would include ordinances that are pertinent to students including noise violations & regulations, rental housing inspection program, unruly gathering and the safety enhancement zone ordinances. Brett gave a breakdown of the expenses stating that the cost of mailing them would be \$884.58 for 5,000 mailers. Jana mentioned that this card could potentially be reprinted and sent with any new updates annually. Derek commended students for their efforts and mentioned that the city would need to review before it is printed. Jana asked the committee for a motion to approve the funds to come from the SCLC budget.
  - ii. Motion #2 (Johnson/McMahon) “Move to approve \$1,200 from the SCLC budget to fund the Good Neighbor Mailer project subject to approval.”
  - iii. Motion passed unanimous voice vote.
- c. St. Patrick's Day Safety Enhancement Zone – Christine Wallace

- i. Christine explained that the Safety Enhancement Zone will be sent to Council for an amendment to add St. Patrick's Day to the ordinance. She stated that the proposed amendment is to block the first 17 days of fall and as many as 21 days for the safety enhancement zone to alleviate the chances of the catastrophic event in 2015.
  - ii. Jana stated that as the voice of Cal Poly students, the ASI Board of Directors approved the resolution asking that the fines not be doubled during that time. Danny stated that students are not supportive of the zone and will have students present at the City Council meeting. Dean McMahon stated that the Resolution acknowledged the history of 2015 and was well researched and written. Jana stated that students want to show that they are responsible without the double fines. She reiterated that "St. Fratty's Day is a stigma and NOT a Greek event. Students want it to be referred to as St. Patrick's Day Celebration. Community members were concerned that many of the parties were over 100 people and that there was a long history of party problems.
- d. Party Registration Discussion – Christine Wallace
- i. Christine stated that the Party Registration Ordinance will go to City Council on January 17. She stated that research was done on a variety of programs with party registration requirements. The recommendation to Council will be to create a pilot program for further research.
