**I. Call to Order**

- a. Jana called the meeting to order @ 3:10 p.m.

**II. Approval of Minutes**

- a. Approval of Meeting Minutes #17-06, January 19, 2017
  - i. Motion #1 (Rowley/Wallace) "Move to approve the minutes from meeting #17-06, January 19, 2017."
  - ii. Motion passed majority voice vote with two abstentions.

**III. Introductions**

- a. Jana facilitated introductions and silent roll call was taken.
  - i. With 15 voting members in attendance, quorum was met.

**IV. Open Forum**

- a. None

**V. Community Reports**

- a. ASI President -Jana Colombini
  - i. Jana reported that the Executive Cabinet has added two new members; Secretary of Student Life and Secretary of Legislative Affairs.
  - ii. She stated that Cal Poly hosted the January CSSA Conference. Attendance included ASI President's from all 23 California State Universities. 75 students were in attendance and the conference was a success.
  - iii. She reported that the University Union Advisory Board traveled to Northern California to look at facilities at the Academy of Sciences, Apple Headquarters and San Francisco State University. The focus was to look outside the box for ideas for the University Union at Cal Poly.
  - iv. Jana announced that ASI Election filing has begun for the next ASI President and the ASI Board of Directors.
  - v. She reported that the Good Neighbor Mailer is ready to print and distribute.
  - vi. She gave an update on St. Patrick's Day celebration efforts stating that ASI and Greek organizations have met and discussed a joint message to be sent to organizations for the chance to prove themselves and hold responsible events. Other efforts included messaging on social media, messages to athletics, Greeks planning smaller events, and encourage members to attend registered parties only. ASI will target students that do not represent large group organizations through social media. Danny added that party registration will be filtered and will reject events that do not fulfill the guidelines. Events are encouraged after 11 a.m. Other ideas included organizing a community service trash pick-up and handing out water bottles and provide trash cans. Members recommended mapping out "hot points" of any registered parties.

- b. ASCC President – Michael Constable
  - i. Michael stated that Cuesta is happy to be part of the Good Neighbor Mailer.
  - ii. He reported that Cuesta held Club Day and was a success.
  - iii. He stated that an email will be sent to students regarding the forum for the Rental Housing Inspection Program and to encourage attendance.
  - iv. Michael announced the SLO Food Bank distribution center for all community members.
- c. City Manager –Derek Johnson
  - i. Derek reported that there was a record turnout at the forum for creating the major city goals. They received great feedback.
  - ii. A presentation will be made at the April City Council meeting for major city goals including a multi-model transportation plan, housing, and downtown vitality.
  - iii. He spoke about the recent free expression (Women’s March) and how the city will manage staff, processes and boundaries.
  - iv. He reported that the City will host a special meeting on the Rental Housing Inspection Program to hear concerns and receive preliminary direction from Council. He stated that they could repeal the ordinance or place on the ballot for the next election.
- d. Residents for Quality Neighborhoods-Sandra Rowley
  - i. Sandra reported that RQN discussed the Cal Poly I-Field remodel, the Rental Housing Inspection Program and the staff and faculty housing project.
  - ii. She stated that a report was compiled for the number of parties of 50 or more.

- a. Cal Poly Open House - Rebecca Villalobos
  - i. Andrene announced the 24<sup>th</sup> annual Cal Poly Open House on April 6-8.
  - ii. Rebecca gave an overview of the day’s events:
    - 1. April 6 - Club Preview Night at Farmers Market
    - 2. April 7 – Admitted Students’ Preview Day, Friday Night Invite & Coffee House for parents and supports

3. April 8 - Poly Royal Celebration, Campus Showcase, Poly Royal Parade, Poly Royal Rodeo and Poly Royal Stage
- b. San Luis Obispo Nose Stat Update - Christine Wallace
  - i. Christine shared a graph showing statistics from 2009-2016 for noisy parties. Stats included the highest complaints at 3,123 in 2003 and the lowest at 1,571 in 2016 with a 49% decrease in overall complaints. Since 2010, there has been a 29% decrease in overall complaints and in 2016, 44% of the calls resulted in a DAC or citation. She stated that since the ordinance was adopted, 26 unruly gathering citations have been issued.
  - ii. Christine shared a graph showing the noise and Neighborhood Wellness initiatives from 1993 to current date.
