**V. Community Reports**

**a. ASI President-Jasmin Fashami**

- i. Jasmin reported that Cal Poly and ASI Student Government will host the November California State Student Association conference. She stated that representatives from all 23 California State Universities will be in attendance.
- ii. She stated that she is attending Alumni Weekend as well as the Cal Poly Foundation meetings.
- iii. Jasmin announced that Cal Poly is the official winner of the California Secretary of State Ballot Bowl competition. Participants included UC, CSU and community colleges. Cal Poly received the highest student voter registrations overall with 3,178 registered students. She stated that Cal Poly was acknowledge for their success at the CSU Board of Trustees meeting.
- iv. She reported that ASI Student Government is hosting a donation drive for fire victim's north and south. The collection will be delivered to Meathead Movers to be transported to needed areas.
- v. Jasmin stated that currently there is over \$11,000 in the SCLC budget. She asked members to bring ideas for use of the funds to the next meeting. Members agreed that bike lights are a good use of funds and a proposal will be created.
