ASI BOARD OF DIRECTORS' SUPPORT SB 467 - CALIFORNIA STATE
UNIVERSITY COST OF ATTENDANCE TRANSPARENCY

- WHEREAS: The ASI Board of Directors serves as the official voice of students at California Polytechnic State University (Cal Poly), San Luis Obispo; and
- WHEREAS: The ASI Board of Directors see the importance of the California State University (CSU) system providing prospective students with an accurate estimate of the total cost to attend Cal Poly; and
- WHEREAS: SB 467 (2019-2020)¹, introduced by Senator Bill Monning and co-authored by Assemblyman Jordan Cunningham, seeks to require the CSU to place accurate and comprehensive cost of attendance information for prospective students on their websites; and
- WHEREAS: SB 467 is a bill that was created by Cal Poly students in a Learn by Doing fashion through Professor Den Hartog's Legislative Bill Project course; and
- WHEREAS: If passed, SB 467² would require postsecondary education institutions to be transparent in providing detailed estimates about the cost of housing, food, books, student fees, and other expenses, allowing students and supporters to have an in-depth perspective as to what campus they can afford and what they will need to budget for in the cost of attendance upon accepting admission; and
- WHEREAS: SB 467 will empower prospective students to make well informed decisions about attending a CSU by providing critical financial information if added to the California Education Code; and
- WHEREAS: SB 467 has received co-sponsorship from the California State Student Association (CSSA) as a bill that will serve for the betterment for California State University (CSU) students; and
