**I. Call to Order**

- a. Jasmin called the meeting to order at 3:11 p.m.

**II. Approval of Minutes**

- a. **Motion #1 (Harmon/Shahi) “Move to approve the minutes from meeting #19-06, November 5, 2018”**

- c. **Motion passed unanimous voice vote as amended.**

- a. Silent roll call was taken and introductions were made. With 16 voting members in attendance, quorum was met.

**V. Community Reports**

**a. ASI President-Jasmin Fashami**

- i. Jasmin reported that she and Kabir attended the CSSA conference in San Diego.
- ii. She stated that Student Government is preparing for ASI Election recruitment season.
- iii. She announced that the Grant Family has made a \$50,000 donation to Cal Poly for the civic engagement efforts.
- iv. Jasmin reported that she will be traveling to the Cal Poly Champions Tour as recognition of students who have achieved a level of statewide or national recognition in the academic fields.

- i. Absent

**c. City Manager - Greg Hermann**

- 1. Greg reported that after a successful outreach & survey, the ten priorities will be built into the open forum for communities input to help decide the major city goals through a dot process and public comment.
- 2. He stated that the city is accepting cannabis applications beginning on January 7 and closes on January 29.

**d. Residents for Quality Neighborhoods - Sandra Rowley**

- i. Sandra reported RQN discussed the Marsh Street parking structure and the payment box under the stairs is a safety concern.
- ii. She stated that concern was raised that the red curbs in front of fire hydrants need to be re-painted. She recommended that it could potentially be an IFC project.
- iii. Other discussion included an alternative to the Cal Poly water supply. Marcy recommended having an expert from Cal Poly to address the concern.

## **VI. Business/Discussion Items**

### **a. Annual Review of SCLC Memorandum of Understanding (MOU)**

- i. Mayor Harmon asked if it would be beneficial to have someone from diversity and inclusion background added to the group. Members stated that it could be premature for this year, that many organizations are still building their programs and cannot speak on their behalf. It was recommended that the MOU should be postponed until next month when reports from groups within the city and Cal Poly could be contacted.
- ii. Other recommended changes included adding Geographical Neighborhood Association and Community Member-at-large to the representation of voting members.

### **b. SCLC Budget Discussion**

- i. Jasmin stated that currently there is over \$11,000 in the SCLC budget with an additional \$2,000 once the new MOU is approved. She asked for suggestions for spending some of the money. Suggestions included:
  1. Bike lights & reflectors
  2. Review the Neighborhood Wellness Civility Report and regenerate discussion.
  3. Attendance at the regional Town Gown conference which could include the incoming student leaders, city administration, and president's offices.
  4. Sponsor SLO Solutions as a presenter at International Town Gown Association conference about existing program.
  5. Housing initiatives - Educational off campus guide, marketing for renter's certificate, housing database development site. Potential paid student senior project.
- ii. Jasmin asked members to bring back a proposal to the next SCLC meeting for allocation of funds.

## **I. Neighborhood Wellness Civility Report Update**

- a. Christine presented the "Noise in Review" showing the timeline from 1993-2018 and the actions taken within the timeline. She reported that in 2009 there were 2,584 noisy party violations and now at a new low of 1,439 and a 44 % decrease from 2009-2018.
