I. Call to Order

- a. Mark called the meeting to order at 3:10 p.m.

II. Approval of Minutes

- a. **Motion #1 (Wallace/Crawford) “Move to approve the minutes from meeting #20-01, August 15, 2019 as written.”**
- b. **Motion passed unanimous voice vote.**

III. Introductions

- a. Silent roll call was taken and introductions were made. With 16 voting members in attendance, quorum was met.

IV. Open Forum

- a. Christine announced the passing of former SCLC member, Frank Kassack. Members share a moment of silence.

V. Community Reports

a. ASI President - Mark Borges

- i. Mark reported that a student representative will be selected for the Mass Transportation Committee.
- ii. Mark participated in WOW by hosting Pancakes with the President where he educated students on the importance of civic engagement through the Flex Your Right Campaign.
- iii. He stated that Cal Poly will release the CPX results soon.

b. ASCC President - Lindsay Bachman

- i. Absent

c. Residents for Quality Neighborhoods - Carolyn Smith

- 1. Carolyn stated that at the September meeting, RQN members held a tribute to Frank and stated that he was a key person in keeping noise data. Other discussion items included noise and parking.
- 2. She commended Cal Poly on successful move in days.

d. City Manager - Derek Johnson

- i. Derek announced that French Park is open.

- ii. He was happy to announce that the police department is almost at full capacity. There have been challenges in recruitment and retention.
- iii. He stated that Bishops Peak is closed for the annual maintenance
- iv. Derek commended Jo Campbell, and UPD on move-in day. No complaints, no back up, and little traffic. He stated it was well orchestrated.
- v. He reported that the Census project proposed an outreach and communication plan with a “best practices kit” to help educate the importance of an accurate count.
- vi. Palm Street parking and the SLO Repertory relocation will be discussed at the November 5 City Council Meeting.
- vii. Other topics of discussion for Council on October 1 & 15 will include:
 - 1. A study session on shared bicycle services
 - 2. A report of tourism business improvement district
 - 3. An appeal on the Montelban Housing project
 - 4. State requirements for building codes
 - 5. Extended business hours for Taqueria Santa Cruz

VI. Business/Discussion Items

a. Cal Poly Move-in Recap – Dr. Jo Campbell

- i. Dr. Campbell shared a video that was presented to incoming freshmen showing Cal Poly pride. She stated that with 11,000 volunteers including 500 staff members, move in was a success. She reported that 7,800 students moved in and they were pleased with the format and anticipate no changes for next year. Members commended University Housing and University Police Department on a job well done.

b. WOW Status Update

- i. Mark gave an overview of Week of Welcome and the activities throughout the week.

c. Parking Discussion

- i. Mark opened the discussion stating he is asking for key points to understand parking issues in the community. Once information is gathered, he will invite parking experts from Cal Poly and the City of San Luis Obispo to the next meeting to address the main issues.
- ii. Derek stated that there is a comprehensive parking study session that can be reported on at the next meeting.
- iii. Carolyn identified the problem of daytime commuter parking which fills the neighborhoods with cars. She suggested a park and ride on campus.
- iv. Other key points included:

1. Night time parking from visitors at parties.
 2. Concerns for traffic, noise, speeding, and blocking driveways.
 3. Students can't afford to park on campus.
- v. Recommendations included:
1. Park and ride or ride share
 2. Making all neighborhoods require a permit.
 3. Campus mobile app should add a ride share option.
 4. Strong education to students on alternate transportation
 5. E-bikes
 6. Utilize empty parking lots i.e. church lots
- vi. Mark closed discussion stating he will invite key staff members to the next meeting for presentations on future steps.

- a. Christine gave an update on noise data for August.
