RESOLUTION TO AMEND THE CAL POLY ACADEMIC GRADING SCALE

WHEREAS: The ASI Board of Directors serves as the official voice of students

at California Polytechnic State University (Cal Poly), San Luis

Obispo, and

WHEREAS: Students are currently unable to receive an "A+" on their

transcripts in part due to the Cal Poly AS-118-81 resolution passed

in 1981¹; and

WHEREAS: The cited Academic Senate Resolution does not provide any room

for an "A+" to be counted since "the grade A already indicates an excellent achievement of course objectives. It is expected that offering a grade level above 4.0 would lead to a downward adjustment of GPAs (Grade Point Average) by employers and

graduate schools."2; and

WHEREAS: This can give a competitive advantage for Cal Poly students

applying to postgraduate education programs. An A+ in a course specific to the program a Cal Poly graduate is applying to can show admissions staff their excellence in a subject, more than an

"A" can³;

WHEREAS: This advantage is most prominent for students applying to any

Law School Admissions Council programs which evaluate

transcripts themselves and award 4.33 grade points for each A+. A student's GPA is one of the best variables to predict success in law school and is a metric law schools rely on heavily for admissions⁴;

and

WHEREAS: This are three other California State Universities (CSUs), California

State University Monterey Bay, California State University Fullerton, and California State University Channel Islands that currently allow for the usage of an "A+" for their grading scales⁵;

and

WHEREAS: This Studies have shown that "Relative Autonomous Motivation"

positively affects academic performance through deep strategy towards study and higher study effort" wherein autonomous motivation refers to intrinsic goals that are self-assigned such as

higher GPA⁶; and

bureaucratic changes throughout Cal Poly; and
